Fall is approaching fast and the Board of Governors is looking to plan for our annual Wine and Cheese Party. We are seeking someone who is willing to host this event for some time in late September or early October (preferably on a Saturday night). This is an adults only event for which the board provides the party supplies (disposable plates, cups, napkins, etc) and the guests bring the wine (or beer) and an appetizer to share—we try to make it as easy as we can for the host. We normally have between 25-40 people in attendance. Please let me know if you are willing to volunteer for hosting and I will be glad to answer any questions you may have. It's a fun event and a great way to get to know your neighbors!

## Coming soon! New Radebaugh Neighborhood Park

When the Radebaugh Florist family said in 2016 they were interested in selling their greenhouses south of Burke Ave to Baltimore County (but keeping the greenhouses at the store at [120 E. Burke Ave](#), and also on Grandpa's farm north of Towson), the Green Towson Alliance (GTA) jumped into action to spearhead the formation of a new neighborhood park. The Alliance successfully lobbied to secure \$1,275,000 from the State and \$175,000 from the County to tear down the industrial buildings, and to grade, add topsoil, and seed the 2.4 acres of land. This year, they secured \$100,000 more for benches, a walking path and a bike rack, and the current County administration has agreed to provide 80 shade trees in 2020. All the funds were secured with help from Delegate Lafferty, ex-Senator Brochin, Senator West and Councilman Marks, and Dr. Carol Newill is the leader of the GTA Workgroup that has persisted in this effort. At this point, most of the land has been graded and grass is starting to grow. Located on 11 Maryland Ave, the park is hoped to be completed and open to the public in 2020, after the grass has grown in enough. Visit Radebaugh Florist and thank them for making the new park possible!

During the formation of the Park, the Six Bridges Trail Project was formed, led by David Riley (current President of Knollwood Community Association), to improve the walking trail and its bridges on the Western Branch of the Herring Run. The trail begins at Stevenson Lane, goes north past Towson High, and will end in Radebaugh Park. The trail crosses six bridges over the winding stream, hence the name. Currently no funds have been allocated for this project, but the Six Bridges Trail Project obtained a grant to address the flooding by the bridge near Stevenson Lane. In the section going north from Aigburth Rd and connecting to Radebaugh Park, the hope is to build a boardwalk trail which will not disturb the sensitive ecology of the riparian buffer along the stream.

## A Message from the Board of Governors

For those Fellowship Forest residents who may be unfamiliar with the neighborhood association and the role of the board of governors (BOG), we thought it would be helpful to summarize those duties.

The primary goal of the BOG is to foster communication and promote fellowship within the community. We try to accomplish that goal through organizing various social events, updating our neighborhood directory, and sending out periodic emails and newsletters about local issues we think you may be interested in. Occasionally, the BOG will also spearhead special efforts to improve /enhance our neighborhood or resolve communal problems. However, the BOG is NOT responsible for addressing/responding to complaints regarding other neighbors. There are no covenants in Fellowship Forest and the BOG has no enforcement authority. In the event that you are having problems with a neighbor, we would first encourage you to try to work it out diplomatically. If that approach is not effective, you also could contact the Baltimore County Code Enforcement Office to determine if there is a specific code violation that they could help get resolved. There is an easy-to-use BaltCoGo app you can download on your smart phone to report violations.

The most common complaints that we receive include:

- Properties that are not properly maintained (i.e., overgrown vegetation, dilapidated buildings, trash, etc.).
- Barking dogs; Dog poop not being picked up.
- Noise (usually from parties).
- Traffic (people driving too fast)

We would encourage all residents to be respectful of their neighbors and be aware that how we collectively maintain our properties has a direct impact on our quality of life and our property values. Finally, we would encourage anyone interested in attending a board meeting or getting involved with the community to contact a board member. The BOG can always use a helping hand and it is great way to get to know your neighbors.
